

# REALTOR® of the Year

To recognize Professionalism through Participation, Education and Service

**PURPOSE:** The primary purpose of the REALTOR® of the Year Award is to recognize and reward high professional achievement of a member who seeks excellence through education and who voluntarily contributes his/her time and skills to their community and the local Board.

**ELIGIBILITY:** Broker-owners, Broker Office Managers (DRs), and members who have held the position of President or President Elect of the board are eligible to apply for this award. Broker Salespersons and the current year's President are not eligible for this award. The REALTOR® of the Year Award is designed for both new REALTORS® and for those who have held membership for many years. Emphasis is placed on recent activities and contributions rather than past achievements, since the basic concept is to award qualification points for the current period. A REALTOR® of the Year award recipient will be ineligible for the 4 four years following receipt of the award.

**QUALIFICATION:** The qualification period is from October 1st to September 30th. **Applications must be submitted no later than October 31st of the qualifying year.** Applicants may re-qualify every year, with the exception of award recipients, who are ineligible for the 4 years following receipt of the award. Yearly qualification is required in order to encourage continuing activity and involvement. An application form is on the following page. It lists, in detail, the point breakdown by category. To apply for consideration, you need to complete the form and return it to LOBR, PO BOX 507, Sunrise Beach, MO 65079 or fax it to 374-2731. The LOBR Awards Committee may, at its discretion, require complete documentation of a member's participation. **To qualify, applicants must have points in Sections A, B, and E.**

**AWARDS:** The Award will be presented at the annual Installation Banquet.

**SELECTION:** The REALTOR® of the Year will be selected based on total points. In the event of a tie, the Awards Committee may ask the contenders to submit an essay. The subject and length of the essay will be determined by the Awards Committee.
